In late 2015, shippers simultaneously filed a declaratory order proceeding in U.S. District Court for the District of Columbia and petitioned the STB to determine whether railroads had a common-carrier obligation to handle traffic for which Congress required PTC installation if they could not meet the end-of-year deadline for installing PTC. Before the STB and court could resolve the issue, Congress mooted it by extending the PTC deadline. Using the existing record, panelists will debate whether the PTC mandate trumps the common-carrier obligation.


